Your group’s liability waiver form(s) may be substituted if approved by the WMGC Board of Directors. For recurring events, either of these forms may be provided once per annum.
- No alcohol is allowed on WMGC property. (WMGC members are responsible for their guests; first violation of member [or guest] will result in a written warning; second offense will result in forfeiture of membership.)
- Participants must follow all safety rules, target and ammunition requirements listed in the **“RELEASE, WAIVER, INDEMNIFICATION, HOLD HARMLESS, AND ASSUMPTION OF RISK AGREEMENT”** and **“RANGE RULES AND OPERATIONAL PROCEDURES”**
- The facilities used must be cleaned to the original condition after your event.
- The user is responsible for any damage to the facilities used.
- The decision of the WMGC Board of Directors relative to this request is final.
